This category entitles all full time employees and their subsidiaries to participate in DiMA activities. Regular members participate directly in association activities and play a major role in shaping and promoting the industry. Members in this category have full voting rights and can participate at the Board of Director level within DiMA. Dues are based on number of full time employees. This membership category has full voting rights.

**Digital Media Associate Member:** Associate membership is available for suppliers, vendors and consultants to the digital media industry. Associate membership is a corporate-level membership for those who are primarily affiliated with or doing business with the digital media industry. It provides multiple channels for reaching and influencing decision-makers. Associate members receive tangible benefits including the ability to network with other DiMA members and stay fully informed of the issues surrounding the digital media industry. Annual dues are determined by a company's gross annual revenue within business unit. Venture capital firms membership dues are based on funds under management. This membership category does not have voting rights.
